### 5. ACKNOWLEDGMENT, ASSUMPTION OF RISK & RELEASE

As the parent or legal guardian of the minor named above, I acknowledge and agree to the following:

- I have read and understood the Charter Service Agreement & Liability Waiver executed for this charter, and I accept its terms on behalf of the minor.
- I understand that commercial sportfishing involves inherent risks including motion sickness, weather exposure, hook and tackle injuries, fish bites, vessel movement, and other hazards. I voluntarily accept these risks on the minor's behalf.
- Emergency Medical Authorization.** I authorize the Captain, crew, any emergency responder, the United States Coast Guard, and any treating medical professional to obtain and provide such emergency medical treatment, diagnostic procedures, hospitalization, surgery, or transportation as may be necessary for the minor's welfare during the charter — including transport to shore by Coast Guard helicopter, vessel, or other means; emergency medical air-evacuation if required; and treatment by paramedics, ER physicians, or hospital staff. I agree to be financially responsible for all such treatment costs, transportation costs, and incidental expenses, and I authorize release of medical information to insurance carriers and to the Captain solely for trip documentation and emergency response.
- Mature-Minor Caveat.** The minor's own assent or signature (if any) does NOT substitute for or limit the parent/guardian's release herein. California does not recognize a strong "mature minor" exception in this context; the parent/guardian's signature alone is the binding waiver for purposes of this engagement. Enforceability of this release in a maritime context is subject to applicable U.S. maritime law.
- The minor will at all times be under the supervision of either myself (as Parent/Guardian) or the designated supervising adult listed above. The Captain and crew are not responsible for the day-to-day supervision of the minor.
- The minor will wear a USCG-approved Personal Flotation Device (PFD) when directed by the Captain or in rough seas, regardless of the minor's swimming ability.
- I RELEASE and HOLD HARMLESS Ironclad Sportfishing Inc., its officers, directors, shareholders, owners, employees, captains, crew, agents, and the vessel F/V Ironclad from any and all claims, demands, or causes of action arising from the minor's participation in this charter, except in the case of gross negligence or willful misconduct.
- I represent that I am the lawful parent or legal guardian of the minor with full authority to execute this acknowledgment on their behalf.

**Seaman Non-Waiver.** Nothing herein waives, limits, or releases any seaman remedy of any captain or crew member under the Jones Act (46 U.S.C. §30104), General Maritime Law, or any other applicable law. The inclusion of captains and crew in the Released Parties is limited to ordinary-negligence passenger claims and does not affect crew members' own rights.
